

## Conditions of the insurance policy for diving and snorkeling professionals

As per the recent decision taken by the CDWS' board members, it has been decided that getting insurance for diving and snorkeling accidents is a new requirement for requesting or renewing the CDWS ID card of the diving and snorkeling professionals. The insurance policy should go in accordance with the following requirements:

- 1-The policy must be by one of the insurance companies that are approved by the Egyptian General Financial Control Authority.
- 2- The policy coverage must fulfill all the conditions stated by the CDWS.
- 3- The minimum insurance coverage must comply with the stated amounts by the CDWS.

Conditions of the insurance policy for diving and snorkeling professionals	Minimum Insurance Coverage
1- Medical evacuation in case of diving accident/injury: to the nearest appropriate facility (including suspect DCI cases) limit	€ 30,000.00
2- Medical evacuation in case of Snorkeling accident/injury: to the nearest appropriate facility limit	€ 15,000.00
3- Emergency Medical Treatment for diving accident/injury: Emergency treatment of DCI and Diving related Injuries, including Hyperbaric Therapy and Hospitalization (including First Diving Emergency Medical Assessment and Hyperbaric Pressure Test in case of Suspect DCI) limit	€ 30,000.00
4- Emergency Medical Treatment for snorkeling accident/injury: Emergency treatment of snorkeling related Injuries Hospitalization limit	€ 15,000.00
5- Specialized Medical Treatment for diving and/or snorkeling accidents: Necessary after a diving accident (early post-acute care, incl. rehabilitation and post-traumatic stress treatment) - up to 30 days from date of incident and always in the country where the Diving/snorkeling accident took origin limit	€ 1,500.00
6- Search & Rescue Expenses for diving and/or snorkeling accidents: following Diving/snorkeling accident only, including cave diving limit	€ 10,000.00
7- Death: in case of diving-related accident and/or snorkeling-related accident limit	€ 10,000.00
8- Permanent Disability: in case of diving related accident and/or snorkeling-related accident limit	€ 5,000.00
9- Professional Liability in case of diving related accident and/or snorkeling-related accident Limit	€ 25,000.00
